AWSC – Trail Passes

We are at that time of the season where you can go riding pretty soon if you have not already. Remember, in order to purchase your trail passes at the discounted rate of \$10 per sled your dues must be current with the Back 40 and the AWSC. Your Membership with the Back 40 also includes membership to the AWSC, the opportunity to purchase your trail passes for each sled at the discounted rate of \$10 each, 8 issues of the WSN magazine. Also, each AWSC household member along with children under the age of 19 receives a \$3,000 Accidental/death insurance policy from American Life Insurance at no cost. Please make sure when you send in your dues that your name and mailing address is listed the same as what you have on your sled registration. If you have a family membership, make sure to include the names that your sleds are registered under. If you have a Commercial Membership, please indicate the name of the individual who the sled is registered in. You can purchase your Trail passes online through www.awsc.org
